Introduction

In December 1997, a white paper entitled 'Designed to Care' was published. It recommended a greater patient perspective in health care and a reduction in the number of trusts in Lothian from six to three. In April 2000 the West Lothian Healthcare NHS Trust was established.

It was the only integrated trust providing both primary (GP and community) and secondary (hospital) care for the population of West Lothian, part of West Edinburgh, and, for some specialist services, for the south-east of Scotland. As well as St John's Hospital and the psychiatric hospital at Bangour Village the trust also had two small hospitals for the elderly, St Michael's Hospital and Tippethill House. It also offered a wide range of outreach services, community health and GP services, based in a number of associated premises including some 12 health centres and clinics. West Lothian Healthcare NHS Trust has now been absorbed into NHS Lothian.

In March 2003, the NHS white paper 'Partnership for Care' was published. This recommended the dissolution of NHS trusts and a move to a single system with decision making being taken at local level. Contracts were transferred from various trusts and boards to NHS Lothian. This resulted in the dissolution of the trusts. On 1 April 2004 West Lothian Healthcare Trust was dissolved to become an operating division of Lothian NHS Board, known as West Lothian Healthcare Division.

It should be noted though, that the West Lothian administration continued to use the term Healthcare NHS Trust after the change over. Because of this and for ease of use, it was decided to keep these papers together rather than split them across two fonds.

The papers were not divided by meeting and in some cases it has not been possible to allocate them to a particular meeting. Entries do not therefore include file titles but details of the type of meeting and its content. Where a full set of agenda papers is provided, this is indicated in the entry. There also appears to have been a purely West Lothian Executive Management Team and as the terms are used interchangeably it is not clear.
